
List of items/documents which the K-RIDE (as Public Authority) is NOT obliged to be disclosed under the provisions of RTI Act 2005

Sections 8,9 & 11 of the RTI Act 2005 have identified the information which the public authorities are not obliged to disclose to the applicant. Further, the information which will affect the strategic, scientific or economic interest of K-RIDE may not be disclosed to the applicant. The information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive positions of the third party {Section 8 (1) (d) & 11} including our suppliers vendors, contractors, purchased and customers may not to be disclosed. Information available in respect to fiduciary relationship {Section 8(1)(e)} shall not be shared until serving larger public interest. Also, the information, disclosure of which would impede the investigation {Section 8 (1) (f)} shall be refused. Sensitive information with regard to marketing and sales procurement and works contracting may not be disclosed.

K-RIDE has drawn a list of such items/documents which it is not obliged to be disclosed to the applicant under section 7,8,9 & 11 of RTI Act 2005.
