Whereas the Employer is desirous that the Contractor execute Design and Construction of Elevated Viaduct of length 8.960 km and At-Grade Formation of length 37.920 km (excluding Station Buildings) including associated Works between Heelalige and Rajanukunte of Corridor-4 of Bengaluru Suburban Railway Project (BSRP) advertised vide Tender No. K-RIDE/BSRP/16/2023, Dated: 20/01/2023 (herein after called "The Works") and the Employer has accepted the Tender by the Contractor for the execution and completion of such Works and the remedying of any defects therein at a contract price of Rupees______

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
- 2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.
- 3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
- 4. The following documents shall be deemed to form and be read and construed as part of this Agreement,

The documents forming the Contract shall be interpreted in the following order of priority:

- i. This Contract Agreement and the Appendices hereto.
- ii. Letter of Acceptance
- iii. Notice to proceed
- iv. Letter of Bid and the Price Schedule submitted by the Contractor.
- v. Addendums, Corrigendum and Pre-bid clarifications to the Tender
- vi. Contract Data, Special provisions (if any)
- vii. Particular Conditions of Contract (PCC)
- viii. General Conditions of Contract (GCC) / Conditions of Contract (CC)
- ix. Employers Requirements including scope of works, the Schedules.
- x. Technical specification, Safety, Health & Environment Manual
- xi. Design and Drawings
- xii. Any other documents pertaining to tender, issued by the Employer
- xiii. Contractor's Technical Proposal
- xiv. Any other documents pertaining to tender, submitted by the contractor
