Upon the review of the said BOQ file some errors are noticed that requires your urgent attention, pointwise relevant details are mentioned in the adjacent column for your kind reference and necessary action.</p> | <p><b>Errors found in the xls file (BOQ_226702.xls) pertaining to BOQ (Bill of Quantities) are mentioned below:</b></p> <p><u>Price Schedule Form for Foreign Bidders (BoQ2)</u> is not getting <u>Validated</u> upon its completion. An alert message is prompted that requires BoQ1 to be completed at first. It is to be noted that foreign bidders are not concerned with the Price Schedule BoQ1 as this is for Indian Bidders only. This error needs to be corrected so that Foreign Bidders could successfully submit their financial bid.</p> <p>Foreign Bidders are unable to provide the information for <u>Country of Origin</u> and <u>Delivery Date as defined by Incoterms</u> under the relevant columns of “<u>Sheet 2 – Foreign Bidders</u>” as the relevant cells are restricted / blocked by the purchaser.
