The tender includes other designations and in page No.98, SL. No 14 it has been stipulated as "The contractor shall provide, at his own cost, all workers and other employees with necessary tools, shoes, jackets, uniform etc. for effective and efficient discharge of the work contemplated in the contract. Necessary inventory for consumables should also be provided by his so that the work is not hampered at the premises". These two kinds of stipulations have caused confusion regarding uniforms. tools and others. Please clarify in this regard.	This will over and above page No – 98 SI No 04.
